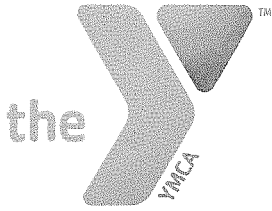

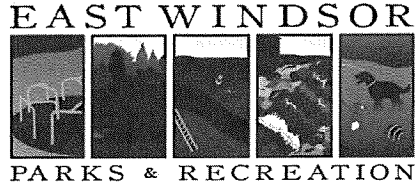

The Connecticut Bar Foundation (CBF) appreciates your bank's participation in the Interest on Lawyers' Trust Accounts and Interest on Trust Accounts (IOLTA/IOTA) program. Enclosed is the CBF 2022 Annual Report listing the legal aid organizations that received funding through this program in 2022.

The IOLTA/IOTA program experienced relatively low revenues during 2020 and 2021 as a result of the precipitous drop in the Fed Funds rate at the start of the pandemic. This was countered to some extent by strength in Court Fee Grants In Aid and direct appropriations (Judicial Branch Grants In Aid). The timing was unfortunate, coinciding with a high level of legal need. Fortunately, interest rates have been rising, which has over time started to produce stronger IOLTA/IOLA revenues. We anticipate that IOLTA/IOTA will provide somewhat higher levels of funding for grantees, and increased legal services for people in need, in 2024.

We are grateful for your bank's continued participation in the IOLTA/IOTA program. ***As interest rates rise, please remember that the rate on IOLTA accounts must be at least as high as the rate offered on comparable accounts at your bank.*** Any increase can make a significant difference in the ability of the most vulnerable residents of our state to access critical civil legal aid services.

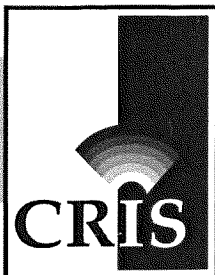
