The Connecticut Bar Foundation (CBF) appreciates your bank's participation in the Interest on Lawyers' Trust Accounts and Interest on Trust Accounts (IOLTA/IOTA) program. Enclosed is the CBF 2023 Annual Report listing the legal aid organizations that received funding through this program in 2023.

2023 was a strong year for CBF financially. The IOLTA/IOTA program interest rates have been rising, which has over time started to produce stronger IOLTA/IOLA revenues. IOLTA revenue saw a significant increase in 2023. The increased revenue from IOLTA, along with the two Judicial Branch grants, has allowed CBF to provide greater support to our grantees, who consistently struggle to meet the legal needs of low-income individuals. In 2023, CBF was able to increase awards to our grantees by 20% for use in the 2024 grant cycle. CBF has long invested surplus IOLTA money in a reserve fund that will allow CBF to support our grantees' funding levels when interest rates inevitably drop. Having a reserve of IOLTA funds, in addition to the Judicial Branch grants, will be critical to ensuring that our grantees can continue their work, even when CBF's income from IOLTA decreases. In 2023, revenues from the IOLTA program represented 17% of the annual grant funding distributed to legal aid organizations.

We are grateful for your bank's continued participation in the IOLTA/IOTA program. ***As interest rates rise, please remember that the rate on IOLTA accounts must be at least as high as the rate offered on comparable accounts at your bank.*** Any increase can make a significant difference in the ability of the most vulnerable residents of our state to access critical civil legal aid services.

If you are interested in becoming a Leadership Bank, please contact our office for more information. Your participation will help to ensure that thousands of low-income Connecticut residents can access legal services to maintain their housing, receive protection from abuse, obtain necessary benefits and many other critical needs. 
